Letter request</li> <li>2. Certified list of employees</li> <li>3. <b>Memorandum Circular No. 13 dated April 21, 2020</b>	Extension of Deadline for Submission of Sustainability Report	<p>The SEC extended the deadline for submission of sustainability report (SR) for publicly listed companies (PLCs) whose fiscal year ends on December 31, 2020.</p> <p>PLCs may file their SR as an attachment to their Annual Report until June 30, 2020.</p> <p>PLCs that have filed Annual Report without SR shall be deemed incomplete annual report, provided that the SR shall be filed until June 30, 2020 by filing an Amended Annual Report.</p> <p>For PLCs that will opt to submit their SR by filing an Amended Annual Report, the submission must be accompanied by the following statements:</p> <ol style="list-style-type: none"> <li>1. That information are true and correct</li> <li>2. That Annual Report had previously been filed and the date of filing</li> <li>3. That the Amended Annual Report is filed solely for purpose of submitting SR</li> <li>4. That the person signing the certification is duly authorized.</li> </ol>

Date, time, place of meeting and other required information</li> <li>2. The availability of electronic copy of Information Statement and Management Report and SEC Form 17A in Company's website and PSE Edge</li> </ol> <p>The Notice shall be published in the business section of 2 newspaper of general circulation, in print and online format, for 2 consecutive days.</p> <p>The last publication shall be made no later than 21 days prior the ASM.</p>

<p><b>Memorandum Circular No. 12 dated April 7, 2020</b></p>	Shareholders' approval on sale of corporate assets	<p>The following rules shall be adopted by publicly-listed companies for sale of corporate assets:</p> <ol style="list-style-type: none"> <li>1. Sale or disposal of corporate property and assets amounting to at least 51% of corporation's total assets shall be considered as sale of all or substantially all of corporate property and assets, whether accrued in single or several transactions taking place within 1 year from date of first transaction (Aggregate sale transaction);</li> <li>2. Vote of stockholders representing at least 2/3 of outstanding capital stock is required for sale of corporate assets;</li> <li>3. In aggregate sale transactions, shareholder approval shall be required for sale transaction that breaches 51% corporate asset threshold;</li> <li>4. Computation of 51% is based on the corporation's latest audited financial statements.</li> </ol>

The corporation may file SEC Form 17-LC, in lieu of written request for extension of filing 17-A or 17-Q reports. The SEC Form 17-LC shall be sent to msrd_covid19@sec.gov.ph and shall be filed no later than 5 days before the regular filing deadline.</li> <li>2. The corporation may file 17-C Report disclosing postponement of annual stockholders meeting, in lieu of Affidavit of Postponement. The 17-C must have and attached Secretary’s Certificate reflecting the Board Resolution on the postponement. <p><b>Notice dated April 2, 2020</b></p> <p>Issued by Corporate Governance and Finance Department</p>	Implementing Rules of Sec. 4(AA) of Bayanihan To Heal As One Act	<p>The “Covered Institutions” shall mean all lenders, including but not limited to banks, quasi-banks, non-stock savings and loan associations, credit card issuers, pawnshops and other credit granting financial institutions under the supervision of the Bangko Sentral ng Pilipinas (BSP), SEC, and Cooperative Development Authority, public or private, including the GSIS, SSS, and PAG-Ibig Fund.</p> <p>All covered institutions shall implement a 30-day grace period for loans with principal and/or interest falling due within ECQ period and shall not charge or apply interest on interest, fees and charges during the 30-day grace period to future payments/amortizations. All covered institutions are prohibited from requiring their clients to waive the mandatory 30-day period.</p>

<b>Memorandum Circular No. 11 dated March 26, 2020</b>	Guidelines for the Submission or Filing of Securities Deposit During the Covid-19 Outbreak and Enhanced Community Quarantine	<p>The SEC provides for the following guidelines:</p> <ol style="list-style-type: none"> <li>Branch offices of foreign corporations duly licensed to do business on the Philippines required to file its initial securities deposit, which deadline falls within the ECQ period, shall have 30 days from lifting of ECQ to file the initial securities deposit.</li> <li>Additional securities deposit shall likewise have 30 days from lifting of ECQ to file an application for substitution of securities.</li> <li>Securities deposit that matured during the effectivity of ECQ shall likewise have 30 days from lifting of ECQ to file an application for substitution of securities.</li> </ol>
<b>Notice dated March 23, 2020</b>	Adoption of Debt Relief Measures	<p>The SEC strongly encourages all FCs and LCs to adopt measures that will help ease their borrowers' financial burden. These companies may develop and implement their own programs or schemes that will provide financial relief to their borrowers. FCs and LCs may implement measures such as, but not limited to:</p> <ol style="list-style-type: none"> <li>Lowering of interest rates;</li> <li>Waiver of reduction of penalties, charges, and other fees;</li> <li>Loan term extension;</li> <li>Suspension of collection;</li> <li>Payment of holiday; and</li> <li>Debt consolidation.</li> </ol>
